

Schedule of Prices 2024-25

RTIG provides services to Members and to others, to facilitate the rollout of effective real time information on passenger transport. Some of these services are free, and some attract a cost (depending on the nature of the service and the grade of membership, if any, of the recipient).

This Schedule provides an overview of charges applicable for services delivered between 1 April 2024 and 31 March 2025.

Membership

Subscription rates for members for 2024-25 are shown in the table below. These reflect an inflationary increase of 3.9%, based on the CPI for November 2023.

There is a discount of 20% for members choosing the five-year option, and a discount of 10% for members choosing the three year option.

The benefits of each grade of membership are described in the latest version of the document "Subscriber Terms and Benefits", reference RTIGC013-1.20 (February 2024).

Smaller operators wishing to join receive a reduce rate and the fees are calculated as a proportionate fee compared to the FULL membership class – based on total group fleet size. The new tiered costs are set out in the table below.

Documentation

Members of all classes have free access to most RTIG documents as a benefit of their membership.

Where a charge applies, it is based on whether the document is "small", "medium" or "large". For 2024-25 the charges, where applicable are as follows:

The charge (or free access by virtue of membership) permits any private use by any incorporated organisation (company, local authority etc) or any of its staff. It does not permit public use, e.g. copying documents or extracts into procurement specifications.



In addition to the document charge, a small administrative fee may be made for producing and issuing documents in hard copy.

Attendance at events

RTIG runs events for the benefits of its members. Employees of member organisations can attend these, but there are limitations on the number of people that can attend for free or by right.

We anticipate again supporting one or more relevant commercial. While these will normally attract a delegate fee, we will negotiate for RTIG members to receive a substantial discount. Full pricing details will be circulated closer to the time.

One-day events will normally be free for members to attend, but there is a restriction on how many representatives each member may send without charge. This number depends on the grade of membership. Non-members may attend, subject to there being space available, but there is a charge for attendance (normally £120 + vat per person). Members may bring additional representatives, or invite guests, but again there is a charge.

Fees will not be chargeable for attendees present at the invitation of the organisers.

Newsletter

The Newsletter operates predominantly as a news distribution service, with feature entries at the editor's discretion. This will focus on items of general value to the sector, especially activities within RTIG and Government announcements related to public transport technology.

Subscription to the Newsletter is free to anyone on provision of a valid email address.

Subscribing members will have the opportunity to submit items for inclusion on a press-release basis, which may be accepted free of charge at the editor's discretion. Non-members do not have this opportunity.

Other notices (e.g. recruitment adverts, product launch adverts) may be placed on a commercial basis. Such notices may be in text or image form and may be up to half a display page. The price for such notices depends on the grade of membership of the advertiser as follows:
