Bus Services Act (2017)

The latest updates from the DfT Bus Open Data Programme are:

Public Consultation response

We realise that operators, local authorities and other industry groups are awaiting the results of the consultation to make informed decisions about their public transport information systems.

Following recent ministerial clearance, the response to the Bus Open Data public consultation is due to be published imminently. It is anticipated the response will be published in mid-March now and potentially supported by a Ministerial visit however confirmation of the exact date to publish is still awaited.

National Fares Data Build Tool

Transport for the North (TfN) has launched a procurement for a National Fares Data Build Tool due to close on 01 March 2019.

The tool is being developed as part of a collaborative partnership between the DfT Bus Open Data programme, TfN's Integrated and Smart Travel programme and Traveline to complement shared ambitions for better provision of fares data on buses.

The proposed Fares Data Build Tool solution will collate public transport operator fares and rules data, and export it in the emerging NeTEx format. The data will enable single, return, day and season ticket fares for bus, ferry and light rail to be displayed in journey planners. The tool will also connect with TfN's Open Data Hub, which is currently in development.

Initially the tool will be launched in TfN's North of England region, with scope to roll out on a national basis. The bid information is now live on the Digital Market Place. The successful supplier will be selected in late Spring 2019, with development expected to commence in June 2019.

Legislation and Guidance

The DfT is working to finalize the Statutory Instrument, which will be laid in June 2019. Following stakeholder feedback from our last Programme Board, DfT officials have recently met with CPT officials to discuss the Statutory Instrument.

The Bus Open Data Programme Board decided not to make use of the option to exempt some small operators from offering location data. The Board also decided to not include a requirement for operators to provide vehicle accessibility data and local authorities to provide stop accessibility data. The Bus Open Data Implementation Group will be meeting again at the end of the month and the DfT will host a location data brainstorming session during the meeting to gather recommendations from the Implementation Group and inform the ongoing development of the guidance.

Digital Project

Following a Government Digital Service workshop in December 2018, the digital project team are delivering some additional user research with data consumers during February. Having tackled bus operators and app developers, our team is now looking at a rarer but still important user group – those who use bus data to build tools for academics, town planners, property developers, engineering consultancies and other non-passenger end-uses.

As a result, we anticipate a two month delay to the commencement of the Bus Open Data beta project and the delivery timescales for complete routes and timetables functionality will now span April –

September 2019 during private beta. This will include routes and timetables publishing functionality, delivery of TransXchange tools, data quality assurance reporting for TransXchange and a review of naptan data. Remaining functionality for location data and fares and tickets information will be addressed during the ublic beta phase which will commence during Autumn 2019.

We are still confident that required functionality will be delivered to align with the requirements coming into effect and are currently considering how a transitional phase will work during 2020. Over the coming weeks, we will be in contact with operators and local authorities to convene early adopters on the Bus Open Data digital service who will help us test and develop the service during 2019 ahead of rollout next year.

Hogia - Another Record Year

For the third year in a row, Swedish IT company Hogia has had a record year: Sales increased from SEK 565 million to SEK 605 million. For the 10th consecutive year employees numbers increased by 25 people bringing the company total to 675. Net profit rose from 34 to SEK 36 million, which is a profit margin of 6%, says Bert-Inge Hogsved, Hogia's founder and CEO.

The business area with the greatest growth in 2018 was the transport sector. Today, this business sector accounts for 30% of the Hogia Group's total revenue. The fastest sales growth being Hogia Ferry Systems.

"Ferries is our most international transport branch with ferry operators using our systems right around the world," says Bert-Inge Hogsved.

"We do not endeavour to maximize profit. Our goal is for the profitability to be just over 4%, which we have achieved for the last twelve years in a row. We invest SEK 200 million a year into the development of our software." says Bert-Inge Hogsved.

Hogia is also investing SEK 160 million in a new office building at their head office in Stenungsund, Sweden. The building will be inaugurated in autumn 2019 and will house a further 200 workplaces.

"Over the last 28 years we have not had a single unprofitable year. We have a very solid financial situation, which means that we can continue to invest long-term. We invest in our products; both the refinement of existing products, and the launches of new cloud-based products. We also continue to attract and develop our expertise. Our year on year growth in personnel of 25 people will




